Lorna McMurray moved to approve a 195 day contract for MaryAnn Johnson to teach Spanish for the 2021-22 school year, beginning in August 2021; seconded by Roger Smidt. Motion passed 5-0 on roll call vote.

Administrator Update

Administrator McNiff informed the ESU 5 board of the progress of the discussion of ESUCC becoming the fiscal agent for the Nebraska PowerSchool Cooperative instead of ESU 5. No board action is required at this time.

Administrator McNiff informed the ESU 5 board that the second COVID vaccine will be given to ESU staff by Public Health Solutions on Friday, April 16.
